At **Mornings with Marilyn** – our **guided meditation app**, your privacy, emotional safety, and personal data protection matter deeply. This Privacy Policy explains what information we collect, why we collect it, and how we keep it safe. We designed this app with trauma-informed principles, which means your emotional and digital safety come first.

By using the Mornings with Marilyn app, you agree to the practices described in this policy.

1. Information We Collect

We collect only what is necessary to operate the app and improve your experience. We do **not** track your personal healing data or the content you listen to.

1.1 Information You Provide

- **Account Information** (if applicable): name, email
- **Payment Information:** processed securely by Apple.
We never see your credit card or payment details.

1.2 Automatically Collected Information

To keep the app running smoothly, the app may collect:

- **Device information** (device type, OS version)
- **Crash logs, diagnostics** (to fix bugs)
- **General app usage information** (e.g., which screens are visited)

This data is anonymous and never linked to your identity.

1.3 Subscription Data (via RevenueCat)

If you purchase a subscription, **RevenueCat** processes:



- Subscription status (active / expired)
- Transaction history needed to verify your access
- Anonymous app user ID

RevenueCat does **not** collect your name, email, or payment details.

2. What We Do NOT Collect

To support a safe healing environment, we do **not** collect:

- Personal meditation history
 - Notes, thoughts, or emotional data
 - Microphone recordings
 - Contacts
 - Location/GPS
 - Health data
 - Sensitive personal details of any kind

3. How We Use Your Information

We use minimal data to:

- Verify your subscription
- Maintain app functionality
- Improve app performance
- Fix bugs and crashes
- Provide customer support

We **never** sell or share your data with advertisers.

4. How We Store & Protect Your Information

We use industry-standard security measures, including:

- Encrypted communication (HTTPS)



- Secure data processing partners (Apple, RevenueCat)
- Limited access controls
- No unnecessary personal data storage

Your data is stored securely and only for as long as needed to operate the app.
